***Applications due: Friday, January 26th, 2024 at noon.***

***Value:*** TBA. This scholarship subsidizes travel and accommodation costs for students who intend to complete a program of study in a Spanish or Latin American country during the Summer 2024 session or one session of the 2024–25 academic year. Winners of this award are not eligible for other future prizes in the Department of Spanish & Portuguese.

***Eligibility:*** Undergraduate students in the Faculty of Arts & Science. Students ***must*** have completed by May 2024 a minimum of one full credit of courses in Spanish at a 200-level or higher. Students in any year are eligible for this award, which is tenable in a Spanish-speaking country in accordance with a study and travel plan approved in advance by the Department. ***Eligible students must demonstrate financial need by qualifying for OSAP assistance for the Winter session in which the application is made.*** From the time of application to the time of travel, it is assumed that the student's financial situation will remain unchanged. The student's signature on this application will authorize Admissions and Awards to release OSAP information to the Awards Committee in our Department.  
Preference will be given to students enrolled in a Specialist or Major program in Spanish.

***Application procedure:*** Submit this application form and an unofficial printout of your transcript. Collate these documents as a single PDF file named: Barker <Your Last Name> 2024.
