***Value:*** Up to \$1,500.00 CAD for one term; up to \$3,000.00 for two terms (Summer 2022, Fall 2022 or Spring 2023) at a university in Spain, Portugal, or Latin America. Final amount subject to confirmation.

***Eligibility:*** Undergraduate students in the Faculty of Arts & Science who have completed between 10 and 16 full credits by the time of application. Student Exchange Program, Self-Designed Program and Woodsworth College Summer Programs are eligible. Students ***must*** have completed at least two (2) full credits in Spanish or/and in Portuguese with a minimum average of B.

***Application procedure:*** Submit this application form, an unofficial printout of your transcript, and a printout of your OSAP assessment of the current academic year. Collate these documents as a single PDF file named: Buchanan <Your Last Name> 2022.
